All mandatory deductions, including income tax and any other applicable statutory contributions, shall be lawfully withheld by Corpsater Construction from your Gross Salary + Net salary on a monthly basis and remitted to the appropriate governmental authorities on your behalf. You shall be responsible for any

additional personal tax liabilities arising under applicable law.

Working Hours & Overtime Policy

You shall be required to work a total of forty-fifty (40-50) hours per week, as scheduled and assigned by your immediate supervisor or reporting manager, in accordance with operational requirements and Company policies. Any hours worked in excess of forty-fifty (40-50) hours per week shall be considered overtime and shall be compensated at the rate of one and a half (1.5) times your regular hourly rate of pay, in strict compliance with applicable labor laws and statutory regulations.

Overtime work, when required, must be authorized in advance by your supervisor or the designated authority. The Company reserves the right to adjust working schedules, shifts, or operational hours in accordance with business demands, subject to applicable labor laws.
